# **A Mission of Light**

Cooperative Employees Bring First-time Electricity to Guatemalan Village.



or the first time, the lights are on in Sillab, Guatemala. Oklahoma's electric cooperatives – in partnership with Colorado's electric cooperatives and the National Rural Electric Cooperative Association's philanthropic arm, NRECA International – brought first- time electricity to the isolated village near the Belize border in the region of Alta Verapaz, Guatemala.

Twenty volunteer linemen, including Heath Gossen & Dusty McNatt with CKenergy Electric Cooperative, spent two weeks at the project site building powerlines and wiring 42 structures, including one elementary school and four churches. The project consisted of some 40-plus poles in approximately 6.5 miles of line and four transformers installed by the linemen. Each home received four lightbulbs, two light switches and two electrical outlets.

Now completed, the power lines will

belong to a local utility, ADECORK (Associación Para Desarollo Communitario Rax Kiche; translation: Association for Community Development Rax Kiche). ADECORK will carry the responsibility of generating and distributing electric power to Sillab. The utility operates a small hydro plant with a capacity of 75 kilowatts (kW).

The locals live in extreme poverty conditions without running water, plumbing and food refrigeration. The villagers depend on farming operations for economic sustainment; they produce corn, beans, cardamom seeds, and some vegetables.

Both men say they were positively impacted by this mission and came home with a changed outlook on life.

The staff and board of directors at CKenergy supported Gossen and McNatt's participation in the project.

"We are proud of Heath and Dusty for selflessly giving their time for an extended period of time to help our neighbors in Central America," says Clint Pack, CKenergy CEO. "This is a powerful way to display one of the cooperatives' core principles, 'Concern for Community,' at home and across the borders."

Electric cooperatives have a long-standing tradition of bringing lights where there are none. More than eighty years ago, cooperatives brought power to rural America and its countryside; given its origins, electric co-ops are willing and well positioned to help other areas that do not have access to electric power.

"Bringing electricity to remote areas in developing countries takes electric cooperatives back to their roots," says Chris Meyers, general manager of the Oklahoma Association of Electric Cooperatives. "It reinforces our commitment to improve the quality of life for local communities at home and abroad. Access to electricity will bring economic empowerment, better access to health care and education and enhanced safety for these villagers. It's a lifechanging gift."

Oklahoma's electric cooperatives have established a 501(c)3 not-for-profit, The Oklahoma Energy Trails Foundation, to support this cause; four projects have been sponsored since 2016. All contributions to the Foundation are tax-deductible. Collectively, Oklahoma's electric cooperatives have made possible 578 first-time electric connections in six villages in Central America and South America.



## A Threat to Co-ops' Tax-Exempt Status



ue to an unintended consequence of current federal tax law, many electric co-ops are finding themselves in a precarious position.

Imagine working hard to secure funding for an important local project only to turn around and give a large chunk of that money back in taxes.

That's the situation many cooperatives, including CKenergy, may face because of recent tax law changes. And it could jeopardize the not-for-profit tax status of cooperatives that receive federal or state government funding of any kind, including disaster relief aid, energy efficiency grants, economic development support and rural broadband development grants.

In order to maintain tax-exempt status, an electric cooperative must receive at least 85 percent of all revenue from its members. However, an unintended consequence of a 2017 change to federal tax law modified the calculation for some contributions by a government entity or civic group.

Now, grants and other contributions may be considered non-member revenue and could threaten a co-op's tax-exempt

status. This would have a profound impact on co-ops and their members. Here are two examples:

- Otsego Electric Cooperative received a \$10 million broadband grant from the state of New York, which will put the co-op well over the 15% limit for non-member revenue in 2019. Otsego will lose its tax-exempt status if the RURAL Act is not passed this year, CEO Tim Johnson said in April. Twenty-one percent of the grant money will have to be used to pay
- West Florida Electric Cooperative Association has received \$24 million in expedited reimbursement from the Federal Emergency Management Agency (FEMA) this year for storm recovery work in the wake of Hurricane Michael in 2018. That's about 40% of the co-op's projected annual revenue. Gulf Coast Electric Cooperative to the south is in the same tax position, and three other Florida co-ops could surpass the 15% threshold by year's end. It's unfair to classify the FEMA reimbursement as revenue—it was for expenses that West Florida incurred to

restore service to a large swath of its members after the category 5 hurricane pounded the Florida panhandle.

Encouraging Congress to fix the tax code to exempt government grants from being defined as member revenue is one of the highest priorities of the National Rural Electric Cooperative Association, the service organization representing America's electric co-ops. Legislation called the Rural Act has been introduced in both the House and the Senate. attracting large groups of bipartisan cosponsors. However, getting it enacted into law will be a heavy lift, given the political sensitivity of tax issues on Capitol Hill.

Congress must act now to correct this unintended consequence and protect the tax status of electric co-ops. In doing so, Congress would preserve the full value of government grants that deliver societal benefits to our communities.

## Don't Wait, Be Prepared Before the Storm



t's your worst-case scenario. A major storm was predicted and this time, the predictions were right. Many power lines are down, and your electricity may be out for several days. You are low on everything—food, pet supplies, toilet paper, batteries, diapers and your medication.

Imagine how you would feel in this situation. While you can't predict which weather forecast will come true, you can plan ahead so when a severe weather event strikes, you have the tools and resources to effectively weather the storm. The Department of Homeland Security offers several resources to help you prepare for major weather events and natural disasters. Visit www.ready.gov/make-a-plan.

## Preparedness Actions and Items

- Stock your pantry with a three-day supply of non-perishable food, such as canned goods, energy bars, peanut butter, powdered milk, instant coffee, water and other essentials (i.e., diapers and toiletries).
- Confirm that you have adequate sanitation and hygiene supplies

including towelettes, soap and hand sanitizer.

- Ensure your First Aid kit is stocked with pain relievers, bandages and other medical essentials, and make sure your prescriptions are current.
- Set aside basic household items you will need, including flashlights, batteries, a manual can opener and portable, battery-powered radio or TV.
- Organize emergency supplies so they are together in an easily accessible location.

## **With Advance Warning**

If a severe storm such as a hurricane is expected with high winds and sustained rain, you may need to take extra steps to safeguard your home. Shutter windows and securely close exterior doors. Fully charge all cell phones, laptops and devices so you have maximum power in the event of a power outage. If you plan to use a small generator, make sure it's rated to handle the amount of power you will need, and always review the manufacturer's instructions to operate it safely.

## **During a Prolonged Outage**

In the event of an outage, turn off appliances, TVs, computers and other sensitive electronics. This will help avert damage from a power surge, and will also help prevent overloading the circuits during power restoration. That said, do leave one light on so you will know when power is restored. If utilizing a small household generator, consider using LED holiday lights to illuminate a living area. A strand of 100 white lights draws little energy yet produces considerable light. Solar lights also work, if they can receive some sunlight during the day for charging.

During thunderstorms, the American Red Cross recommends avoiding electrical equipment and land-based telephones. Use battery-powered TVs and radios instead. Keep away from windows. Listen to local news or NOAA Weather Radio for emergency updates, or check CKenergy's app or social media pages restoration updates.

After the storm, avoid downed power lines and walking through flooded areas where power lines could be submerged. Allow ample room for utility crews to safely perform their jobs – including on your property.

## **Power in Planning**

Advance planning for severe storms or other emergencies can reduce stress and anxiety caused by the weather event and can lessen the impact of the storm's effects. Sign up for NOAA emergency alerts and warnings and like or follow CKenergy's social media pages to stay abreast of restoration efforts and other important co-op news and information. Act today, because there is power in planning.

# **Apple Pie Bites**

## **Ingredients:**

1/4 cup packed light brown sugar

1 teaspoon apple pie spice, and additional apple pie spice (about 1/4 teaspoon) for sprinkling on top of crescent rolls

3 tablespoons butter, melted

1/3 cup chopped pecans

1 small Granny Smith apple, cored and sliced into 8 (1/2-inch) slices

1 (8-ounce) can Pillsbury Original crescent rolls



## **Directions:**

Preheat your oven to 375 degrees. Line a baking sheet with parchment paper. In a small bowl, combine brown sugar and apple pie spice. Set aside. Melt butter and toss apple slices in butter, set aside. Arrange crescent roll triangles on baking sheet lined with parchment paper. Evenly distribute brown sugar mixture onto each triangle. Sprinkle each triangle evenly with the chopped pecans. Place an apple slice on the wide end of each triangle. Wrap crescent roll dough around each apple. Brush each crescent roll with remaining butter. Sprinkle lightly with additional apple pie spice. Bake for 10-12 minutes, or until golden brown. Cool for 5 minutes before serving.
