# October is National Co-op Month

s an electric cooperative, our top priority is always to provide reliable, affordable energy to you, the consumer-members we serve. Because we are a co-op, our mission is to enrich the lives of our members and serve the long-term interests of our local community—and this mission has never been more critical than in recent months. One of the seven principles that guides all co-ops is "concern for community." This principle is the essential DNA of CKenergy Electric Cooperative, and it sets us apart from other electric utilities.

October is National Co-op Month, and electric cooperatives across the country are highlighting the many ways we "Power On."

Who would have fathomed in March, that the COVID-19 virus would amount to a

test of our community and our nation? The changing circumstances due to the pandemic have created both challenges and opportunities. Over the past several months, we've all been challenged to operate differently, and CKenergy has stepped up to help our members and strengthen the safety net for our more vulnerable neighbors.

As an essential service, and to ensure reliability of your power supply, we modified our operations to safeguard business continuity. In the office, we limited and modified meetings and gatherings to allow for safe separation. We also adjusted our walk-in office availability and in-person service calls to ensure the health and safety of our employees and our valued members. In addition, we held a simplified non-traditional annual meeting with a drive-

thru registration option. For the health and safety of everyone, we think these measures were the prudent course of action for the times.

For our members impacted by COVID-19 who needed help with their electric bills, we waived late fees and worked with those hardest hit to make special payment arrangements.

We've seen other local businesses rising to meet similar challenges during this time, because that's what communities do. While the challenges caused by COVID-19 have been daunting, we are heartened to see how everyone is pulling together.

CKenergy Electric Cooperative was built by the community to serve the community, and that's what we'll continue to do – Power On.



# **Electrical Safety Tips for Hunters**

s various hunting seasons continue, please remember that electrical insulators, conductors and electrical equipment are NOT on the hunting season list. In order to stay safe and prevent unnecessary damages, it's important you take certain measures and precautions while hunting.

**CKenergy Electric Cooperative** encourages hunters to be aware of electrical equipment while enjoying the great outdoors.

When deer hunting, it's important to be aware of what's behind that big buck, or it might cost big bucks. Repairs can be costly in both equipment and outages to our members. As non-profit cooperatives, owned by the members, we all share in this expense.

Hunters and other gun owners should not shoot near or toward overhead power lines, power poles or substations. A stray bullet can cause damage to equipment,

could be deadly to the shooter and potentially interrupt electric service to large areas.

Sometimes the damage isn't noticed for several weeks or months, and is only discovered when an unexplained outage occurs.

Landowners are encouraged to remind those hunting on their property to be aware of power lines.

We recognize the majority of hunters practice safe hunting and understand the potential hazards when discharging a firearm. We encourage experienced hunters who are familiar with the area to identify the locations of utility properties and electrical equipment to young or new hunters in their group to ensure they take the proper precautions. Enjoy the great outdoors. Just be sure to hunt only what's in season.

## Hunting **Safety Tips**

- Do not shoot at or near power lines or insulators.
- Familiarize yourself with the location of power lines and equipment on land where you shoot.
- Keep a safe distance from power lines and electrical equipment when hunting. Accidents can be easily avoided if you do so.
- Damage to the conductor can happen, possibly dropping a phase on the ground. If it's dry and the electricity goes to ground, there is the possibility of electrocution and fire.
- Be especially careful in wooded areas where power lines may not be as visible.
- Do not use power line wood poles or towers to support equipment used in your shooting activity.
- Take notice of warning signs and keep clear of electrical equipment.
- Do not place deer stands on utility poles or climb poles. Energized lines and equipment on the poles can conduct electricity to anyone who comes in contact with them, causing shock or electrocution.
- Do not place decoys on power lines or other utility equipment.

Small Change, **Big** Difference!

n Monday, August 10, 2020, the CKenergy Electric Foundation Board approved a total of \$24,930.00 for grants this quarter. Those funds will be used to improve the livelihood of individuals, fund school programs, help local law enforcement better protect citizens, and so much more!

Giving to those in need is a great way to tap into the Oklahoma spirit and thousands of Oklahoma's electric co-op members do just that by donating funds through Operation Round Up.

As a member of CKenergy Electric Cooperative, you have the opportunity to participate in the Operation Round Up program. The program works by allowing co-op members to round up their monthly electric bills to the nearest dollar amount. The spare change is transferred to CKenergy's Operation Round Up fund and dispersed to local charitable causes.

For example, let's say you have a monthly electric bill of \$84.62. The bill is rounded up to a flat \$85, with the additional 38 cents going into the Operation Round Up Fund. On average, a co-op member donates roughly \$6 each year. Seems like a small amount, right? It is, but when multiplied by thousands of other CKenergy members, Operation Round Up raises thousands of dollars for local causes and organizations.

Operation Round Up funds are used to address important local needs. Local charities, youth groups, schools, fire departments, senior citizen's centers and food banks are just a few of the beneficiaries of Round Up funds. Funds are also used to help needy individuals and families pay for medical equipment and other needs.

CKenergy Electric Cooperative is passionate about the communities we serve. Together, electric co-ops with Operation Round Up programs in place have raised more than \$100 million since 1989.

Grants are decided by a twelve-member board of cooperative members who volunteer their time to oversee the program. CKenergy Electric co-op coordinator is Boyd Lee. Requests for assistance are reviewed and evaluated quarterly throughout the year.

We hope you will continue to participate in CKenergy's Operation Round Up. Your small change will change lives, and together we will make a big difference right here in Oklahoma.

Next quarter grant applications must be submitted no later than November 3, 2020. Any applications received after the due date will be on the agenda for the next scheduled meeting.

# **Halloween Popcorn Bars**

### **Ingredients:**

2 tbs. butter 20 large marshmallows 4 cups popcorn ⅓ cup pretzel pieces ⅓ cup candy corn 1/4 cup reese's pieces candy 1 tbs. sprinkles



### **Directions:**
